

**RESOLUTION NO. 437**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF STEVENSVILLE, MONTANA, PROVIDING FOR THE AMENDMENT OF THE BUDGET FOR THE FISCAL YEAR 2018/19**

**WHEREAS**, the Stevensville Town Council adopted the budget for Fiscal Year 2018/19 by Resolution No. 430; and

**WHEREAS**, the Town Council, in its budget did not set an appropriation from the General Fund for the purchase of Council laptop computers; and

**WHEREAS**, the Council requested the purchase of four Chromebook computers and accessories during FY19; and

**WHEREAS**, the cost of the computers and accessories is \$992; and

**WHEREAS**, the requested appropriations must come from the General Fund reserves.

**NOW THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Stevensville, Montana that the fiscal year 2018/19 budget be amended as follows:

**AND WHEREAS**, the Town of Stevensville, through the Federal Aviation Administration, was awarded a grant in the amount of \$165,465 for the design phase of an improvement project;

**WHEREAS**, the grant revenue and associated appropriations were not included in the FY18/19 budget when it was adopted.

**NOW THEREFROE, BE IT RESOLVED** by the Town Council of the Town of Stevensville, Montana that the fiscal year 2018/19 budget be amended as follows:

Revenue	5620-331129	\$165,465
Expenditure	5620-430300-350	167,800

**AND WHEREAS**, the Stevensville Fire Department is a subrecipient of a grant to purchase Self-Contained Breathing Apparatus; and,

**WHEREAS**, the grant requires a match in the amount of \$10,500; and

**WHEREAS**, the Fire Engine Capital Improvement Fund has been maintained as a reserve to cover future equipment purchases.


**NOW THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Stevensville, Montana that the fiscal year 2018/19 budget be amended as follows:

Expenditure 4002-420460-940 \$10,500


