## Public Utiliy Easement and Dedication to the Town of Stevensville

THIS INSTRUMENT, made this 8th day of DECEMBER 20/6,

Whereas: John N. Love and Janice K. Love, Co Trustees of the John and Jan Love Family Trust UTD 12/30/1993, with authority to act either singularly, or plurally, hereinafter GRANTOR, do hereby grant the following:

## WITNESETH

WHEREAS, GRANTOR is the lawful owner of:

Lot 2 Certificate of Survey No. 466881, records of Ravalli County, located in the Northwest one-quarter (NW 1/4) of Section 26, Township 9 North, Range 20 West, P.M.M., Ravalli County, Montana, commonly known as 4038 Eastside Highway, Stevensville, Montana.

GRANTOR hereby grants to the Town of Stevensville, Montana a thirty foot (30') wide Public Utility Easement upon which to construct, operate, maintain, replace or upgrade public utilities or communication systems.

Said easement shall extend eastward from the SW corner of lot 2, thence fifty'feet (50') east to a point extending beyond the existing installed sewer manhole, as shown on Exhibit A, COS No. 466881, Love Commercial Lots, attached and/or incorporated by reference herein.

Grantor hereby dedicates to the Town of Stevensville, Montana the installed sewer line and sewer manhole. Said sewer line is located ten feet (10') parallel to the south boundary of lot 2, within the described easement boundaries. Said sewer line has been tested and certified by Ram Engineering of Hamilton, Montana, to meet State of Montana requirements, and accepted by the Town of Stevensville.

GRANTOR covenants that the Grantor is lawfully seized and possessed of the real estate above described, and that the Grantor has a good and lawful right to convey it, or any part thereof.


