RESOLUTION AUTHORIZING AMENDMENT OF THE FISCAL YEAR 2015-16 BUDGET PURCHASE OF LADDER TRUCK FOR THE STEVENSVILLE FIRE DEPARTMENT

WHEREAS, the Stevensville Town Council adopted the budget for FY2015-16 by Resolution No. 374; and

WHEREAS, the Town Council, in its budget, allocated \$10,000 for the replacement of R2040 (ambulance), with a 50% split share with the Stevensville Rural Fire District as part of the Capital Improvements Fund; and

WHEREAS, the Stevensville Rural Fire District has no current plan for the replacement of R2040 (ambulance); and

WHEREAS, the Town of Stevensville Fire Department has identified the opportunity to purchase a 1985 Pierce 55' Quint (ladder truck) from the City of Columbus, Montana, for a purchase price of \$12,500, and

WHEREAS, the Town Council recognized the need for the future purchase of a fire engine as a legitimate expense in its 2012-17 Capital Improvement Plan and provided for a transfer (set aside) of \$18,000 in the FY 2015-16 budget; and

WHEREAS, The Town of Stevensville maintains a fire engine replacement savings account ending in ...479 as part of its Fire Engine Capital Improvement Fund #4002-101000; and

WHEREAS, pursuant to Sections 7-6-4006, MCA, the Town Council of the Town of Stevensville, Montana has held a public hearing on this proposed amendment to the FY 2015-16 budget as required by law.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Stevensville, Montana, that the amount of \$18,000 be transferred from the Fire Engine Capital Improvement Fund savings account ending in ...479 to CIP Cash Operating Fund #4000-101000.

BE IT FURTHER RESOLVED that the FY 2015-16 budgeted CIP Cash Operating amount of \$10,000 for the replacement of R2040 (ambulance) along with the aforementioned \$18,000 transfer be reallocated for the purchase of and upgrading of a 1985 Pierce 55' Quint (ladder truck).

Councilmembers,

Mayor Ludington asked me to notify you that he is vetoing Resolution No. 383, Resolution Authorizing Amendment of the Fiscal Year 2015-16 Budget Purchase of Ladder Truck for the Stevensville Fire Department, passed by a unanimous vote by the Council on January 28, 2016.

Mayor is vetoing the resolution due to the budget amendment amount having been noticed to the public (Public Hearing Notice) for the amount of \$15,000 (as presented before the Council on January 14th, 2016) and the budget amendment was increased to the amount of \$28,000 when passed.

Resolution No. 383 will be returned to Council at the next Council meeting, February 11th. Council may override the Mayor's veto by a two-thirds vote or the Council may allow the veto to ride and set another public hearing notifying the public of a \$28,000 budget amendment.

WHEREAS, the Town Council recognized the need for the future purchase of a fire engine as a legitimate expense in its 2012-17 Capital Improvement Plan and provided for a transfer (set aside) of \$5,000 in the FY 2015-16 budget; and

WHEREAS, The Town of Stevensville maintains a fire engine replacement savings account ending in ...479 as part of its Fire Engine Capital Improvement Fund; and

WHEREAS, pursuant to Sections 7-6-4006, MCA, the Town Council of the Town of Stevensville, Montana has held a public hearing on this proposed amendment to the FY 2015-16 budget as required by law.

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Stevensville, Montana, that the amount of \$5,000 be transferred from the Fire Engine Capital Improvement Fund savings account ending in ...479 to CIP Cash Operating Fund #4000-101000.

BE IT FURTHER RESOLVED that the FY 2015-16 budgeted CIP Cash Operating amount of \$10,000 for the replacement of R2040 (ambulance) along with the aforementioned \$5,000 transfer be reallocated for the purchase of and upgrading of a 1985 Pierce 55' Quint (ladder truck).
