## A RESOLUTION TO LEVY AND ASSESS CERTAIN LANDS FOR TWIN CREEKS LIGHTING DISTRICT (Phase I of Twin Creeks Subdivision)

WHEREAS, the Town Council of the Town of Stevensville has passed a Resolution to Create the Twin Creeks Lighting District including Phase 1 of Twin Creeks Subdivision; and

- 2. This assessment is assessed, divided equally, against all of the lots in Phases 1 of the Twin Creeks Subdivision; and
- 3. This assessment and levy shall be made in the amounts listed on Exhibit A attached and shall be evenly divided into the two billings for the tax year; and
- 4. The Clerk of the Town of Stevensville shall transmit this Resolution to the Clerk and Recorder for Ravalli County, Montana, to provide for the assessment and levy on the tax rolls of the state and county; and
- 5. All funds from the assessment and levy shall be deposited into a fund known as the "Twin Creeks Lighting District" and any administrative regulations there under; and
