RESOLUTION NUMBER 95

A RESOLUTION EXTENDING THE BOUNDARIES OF THE TOWN OF STEVENSVILLE, MONTANA, TO INCORPORATE THEREIN A CERTAIN TRACT OF LAND WHICH IS NORTH AND WHICH IS CONTIGUOUS TO THE CORPORATE LIMITS OF THE TOWN OF STEVENSVILLE

WHEREAS, in the judgment of the Town Council for the Town of Stevensville, Montana, it is deemed to be for the best interests of the Town of Stevensville and the inhabitants thereof, and also to be in the best interest of the owners of the tract of land described below, which is sought to be annexed, that the corporate limits of the Town of Stevensville be extended to include said tract of land within the corporate limits of the Town of Stevensville, and,

WHEREAS, 100 percent of the owners of said tract appeared and petitioned the Town of Stevensville for annexation of the said tract to the Town of Stevensville, the owners agree to connect to the existing main lines of the water and sewer at the owners expense, at the best point as engineered by the Town and State specifications,

WHEREAS, The Town of Stevensville will provide fire and police protection, and water and sewer services, and

WHEREAS, the property owners agree that this annexation will be zoned Commercial, Cl, and,

WHEREAS, the Town Council of the Town of Stevensville, heard all persons and things relative to the proposed annexation, and the Council found that it is in the best interest of the Town of Stevensville to annex the following described real property, to-wit:

NOW, THEREFORE, BE IT RESOLVED, by the Town Council of the Town of Stevensville, Montana, that the tract of land herein described be in-corp orated into the corporate limits of the Town of Stevensville.

BE IT FURTHER RESOLVED that the annexation of said tract of land shall include all the property described and such annexation shall take effect immediately upon passage and approval of this resolution. PASSED AND ADOPTED this 26th day of January 1987
