RESOLUTION BY CITY COUNCIL #52
OF STEVENSVILLE, MONTANA
DECLARING THEIR INTENT TO
ESTABLISH A CITY PLANNING BOARD

WHEREAS, The City Council determined that the Ravalli County Comprehensive Plan does not include sufficient detail for Stevensville and the area outlined on attached plat, to serve as a guidance policy or as the required statutory support for planning in Stevensville; and,

WHEREAS, The City Council of Stevensville established the Mayor's committee for planning in Stevensville to develop a comprehensive plan for Stevensville and the area outlined on attached plat and a recommendation to implement the objectives of the plan which were consistent with the Ravalli County Comprehensive plan; and

WHEREAS, The City council requests the Ravalli County Commissioners to appoint planning board members as required by Part 2, Section 76-1-201, RCM; and

WHEREAS, The Mayor's committee has reported to the City Council that the Ravalli County Planning Board cannot service as the required review organization for a City planning program; and

WHEREAS, The Mayor's Committee has also reported to the Council that a City Planning Board or a City-County Planning Board established pursuant to Section 76-1-105 MCA is required to implement a planning program in the area outlined on the attached plat; and

WHEREAS, The committee has recommended that a City-County Planning Board with a planning jurisdiction which includes Stevensville and the area outlined on attached plat; to,

1. Review, amend, and recommend to the City Council a Stevensville Comprehensive plan for Stevensville and the outlined area.
2. Monitor, the implementation of the Stevensville Comprehensive Plan and make annual reports to the City Council for amendments and implementation programs.
3. Serve as the Stevensville Zoning Commission should a zoning program be adopted for Stevensville and the outlined area.

Dec 1980 City Council
Intent to Establish a City Planning Board

WHEREAS, The City Council has determined that such a board would not duplicate the functions of the Ravalli County planning Board but would enable a more concentrated planning program for Stevensville; and,

WHEREAS, Pursuant to Section 76-1-105 MCA the City Council must notify the County Commissioners of it's intent to form a City Planning Board and the County Commissioners may elect to form a City-County Board or to permit the City to Form a City Planning Board;

NOW THEREFORE, Be it resolved that the Stevensville Council wishes to establish a City-County Planning Board and requests the Ravalli County Commissioners to cooperate in the establishment of such board, and

FURTHER, The City Council requests that the County exercise it's option to establish a City-County Planning Board, appoint four County representatives pursuant to Section 76-1-201 and Section 76-1-202 MCA, and adopt the attached map as the official planning jurisdictional map for Ravalli County Planning Board and the Stevensville City-County Planning Board; and

FURTHER, That the County Commissioners notify the City Council, in writing, within 30 days of it's agreement with this resolution.
