A RESOLUTION EXTENDING THE BOUNDARIES OF THE TOWN OF STEVENSVILLE, MONTANA, TO INCORPORATE THEREIN A CERTAIN TRACT OF LAND WHICH IS WEST AND WHICH IS CONTIGUOUS TO THE CORPORATE LIMITS OF THE TOWN OF STEVENSVILLE AND BEING DESCRIBED AS CERTIFICATE OF SURVEY No. 1558 and hereafter TO BE KNOWN AS THE BLAKESLEE ADDITION TO THE TOWN OF STEVENSVILLE, RAVALLI COUNTY, MONTANA.

WHEREAS, the Town Council of the Town of Stevensville heard all persons and things relative to the proposed annexation, and the Council found that it is in the best interests of the Town of Stevensville to annex the above-described tract of land, and

NOW, THEREFORE, BE IT RESOLVED BY the Mayor and Council of the Town of Stevensville, Montana, that the tract of land herein described be incorporated into the corporate limits of the Town of Stevensville as follows: Certificate of Survey No. 1558, as filed with Ravalli County.

AND BE IT FURTHER RESOLVED that the annexation of said tract of land shall include all the property described and such annexation shall take effect immediately upon passage and approval of this resolution.
