A RESOLUTION REGULATING THE MOVING OF ANY HOUSE OR STRUCTURES INTO OUR OF, OR WITHIN THE TOWN LIMITS OF THE TOWN OF STEVENSVILLE, RAVALLI COUNTY, MONTANA; PRESCRIBING A LICENSE FEEL FOR SUCH ACTIVITY AND FURTHER PRESCRIBING PENALATIES FOR VIOLATION AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT RESOLVED BY THE COUNCIL OF THE TOWN OF STEVENSVILLE, MONTANA:

SECTION 1. House Moving: Any person, firm or coporation engaged in the business of moving any house or structures into, ou of, or within the Town limits shall first obtain a House mover's License, the annual fee for which shall be fifty dollars (\$50.00) per year. Any person, firm or corporation desiring to obtain such a license shall make application to the Inspector of Buildings and shall also submit a property damage and personal liability insurance in the amount of fifty thousanddollars (\$50,000.00) property damage and one hundred thousand to three hundred thousand dollars (100,000.00/\$300,000.00) personal liability. Upon presentation of such application bond and policy or policies the said Inspector of Buildings shall examine the qualification and equipment and make a report on the same to the Governing Body at a regular meeting together with such application, bond policy or policies and said Governing Body in a regular meeting may thereupon authorize the issuance of such license and direct the Clerkof the Town to issue the same upon payment of the annual license fee.

Thereafter, before any house or structure may be moved into, out of or within the Town, such licensed house movers shall make application for a permit for the moving of each separate house or structure to the Inspector of Buildings and said Inspector of Buildings shall inspect the same and the route upon which house or structure is proposed to be moved, and no permit shall be authorized by the Inspector of Buildings of said house or structure is over twenty four feet (24') wide of an all over height, while moving of twenty feet (20') or over and weighs over forty (40) tons without approval thereof of a majority of the Governing Body inregular session. any event all house moving shall be under the supervision of the Inspector of Buildings of the Town; and the said Inspector of Buildings may demand any precaution by him deemed to be advisable for the protection of the streets; and no house or structure shall be moved which shall necessitate an extensive deprivation of the citizens of the Town of any public service, and any mover shall make his own arrangements with all public utilities, Fire Department and Park Department, either by agreement or under provisions of the State for such moving and shall furnish proof of such agreement on forms supplied by the Inspector of Buildings. Each application for a House Mover's license shall furnish proof of compliance with all Montana regulations for such moving.

SECTION 2. Fees for the issuance of a permit to move any house or structure shall be as follows: Structures less than fourteen feet wide (14') and less than twenty two feet (22') in length and less than fourteen feet (14') in height, a fee of twenty five dollars (\$25.00) each.
