

RESOLUTION NUMBER 18

A RESOLUTION EXTENDING THE BOUNDARIES OF THE TOWN OF STEVENSVILLE, MONTANA, TO INCORPORATE THEREIN A CERTAIN TRACT OF LAND WHICH IS SOUTH OF THE CORPORATE LIMITS AND IS CONTIGUOUS TO THE CORPORATE LIMITS OF THE TOWN OF STEVENSVILLE AND DESCRIBING THE BOUNDARIES THEREOF: BLOCK ONE (1) of the GEORGE A. SMITH SUBDIVISION.

WHEREAS, in the judgement of the Town Council of the Town of Stevensville, Montana it is deemed to be for the best interests of the Town of Stevensville and the inhabitants thereof, and also to the best interests of the owner of said tract of land sought to be annexed, that the corporate limits of the Town of Stevensville be extended to include said platted tract of land within the corporate limits of the Town of Stevensville, and

WHEREAS, there was duly and regularly passed and adopted by the Council of the Town of Stevensville, and approved by the Mayor on the 18th day of 1976 Resolution Number 18 proposing the extension of the City limits to include above mentioned property' and describing the boundaries thereof, and

WHEREAS, the Clerk of the Council did give and publish notice of such proposed extension of the Town limits as provided by law, and

WHEREAS, either no valid protests, or less than the statutorily prescribed percentage of protests to the extension of said corporate limits of the Town of Stevensville, were filed with the Clerk within the time allowed by law, and

WHEREAS, the City Council of the Town of Stevensville heard all persons and things relative to the proposed annexation, and the Council found that it is in the best interests of the Town of Stevensville to annex the above-mentioned tract of land, and

NOW THEREFORE, BE IT RESOLVED BY the Mayor and Council of the Town of Stevensville, Montana that the tract of land herein described be incorporated into the corporate limits of the Town of Stevensville as follows:

BLOCK one (1) of a tract of land in the  $S\frac{1}{2}S\frac{1}{2}$  section 27, T9N, R20W, P.M.M., Ravalli County, Montana described as follows: all of the  $SW\frac{1}{4}SE\frac{1}{4}$  section 27, T9N, R20W, P.M.M., lying West of the State Highway 269, also a parcel described as beginning at the south center  $1/16$  corner of Section 27, T9N, R20W, P.M.M., a corner of record, thence south, 1227.44 feet; thence  $S89\ 49'21"W$ , 60.00 feet; thence North, 1227.44 feet; thence  $N\ 89\ 49'21"\ E$ , 60.00 feet to the point of beginning, containing 35.144 acres, more or less, to be known as the George A. Smith Subdivision and all lands in streets and avenues shown on said plat are hereby donated, granted and dedicated to the use of the public forever, also all water and sewer lines in the Block one are deeded to the Town of Stevensville, Montana.

AND BE IT FURTHER RESOLVED THAT THE Annexation of said tract of land shall include all the property described and such annexation shall take effect immediately upon the passage and approval of this resolution.
