All public comment could be directed to the chair (Mayor or designee). Comment made to the addience or individual council members may be ruled out of order. Public comment must remain on topic, and free from abusive language or unsupported allegations.

During any council meeting you have two opportunities to comment.

- 1. During the public comment period near the beginning of a meeting.
- 2. Before any de making vote or me council on an agenda item.
- 3. Comment made outside of the times may not be allowed.
- 4. Citizens wishing to speak during the official public comment period should come forward to the pocket and state their name and address for the record. Comment during this time maybe time writed, as determined by the chair, to allow as many people as possible to comment.
- 5. Citizens wishing to comment on a motion for decision before any vote can come forward or stand in place as they wish. Comment must remain on the motion before the council.
