Brian Germane, Airport Manager: no new maintance items, coming to an end with the mowing, start converting things over for plowing. CIP projects as we have discussed the FAA has been extremely slow with the grant paperwork this year, we have only received our grant paperwork for the tank we have not received the grant paperwork for the asphalt maintance project. somehow that ended up in their last round of paperwork, we are quickly running out of our window to get that asphalt done, hopefully we will get that pretty soon and get that executed. They have this deadline of the 16^{th,} and we are not sure how that is going to work out, there has to be some flexibility. Sold approximately 6,800 gallons of fuel, expecting to purchase another round of fuel later on in October. The Forest Service, they did not end up in a location that would activate their agreement with us.

d. Fire Department

Chief Motley: in the packet. (read through the stats) There is a staffing issue on the missed calls during the daytime, those that can leave work or not. We are missing out on some calls that way again we are trying to bolster our EMS people among the staff and what we run into is training. Training is expensive and we do not have the budget to do that with. We will do the best that we can to keep that up I feel that it is

s need to provide that care in the community. We are going to be conducting our annual pump tests this Friday with the district. The contractors are coming down to do all of the apparatuses at one time, save some dollars. Should be hearing on the radio grant soon, so we will see what happens. In 2026 the Stevensville Fire Department and Rural Fire Department will joining together to host the Montana State Firefighters convention here in the town of Stevensville, looking at bringing in 200-250 out here from around the state. Working on that. Last year it was in Libby and now it is going to come here, great training opportunity for us.

Councilmember Smith: can you give me an estimate on how much it costs to train an EMT.

Chief Motley:120 hours, class costs around \$1,000.00 per student. That is within the Ravalli County Fire Council, if you go outside of that it is anywhere between \$1,500.00 and \$2,500.00.

Councilmember Barker: how many hours?

Chief Motley: 120 hours of class time, 24 hours of ride along time, and 24 hours emergency room time.

e. Police Department

Chief Boe: in the packet. First thing I wanted to say is Reverand Scrivner is here, and this was his brainstorm, and I met about this with him. Thank you Chief Motley for assisting us with the silent presession. It was an honor for myself and my staff to participate in something like this. (read through the stats).

f. Public Works

Stephen Lassiter, Public Works Supervisor: in the packet. Leak on Spring Street, thought that we had it, it sprung another leak. An old, galvanized line, fixed it. I read one thing that we never see any results this water increase, we never see anyone on the street. You would have to be in my hip pocket to see me and what we do every day, we have had three burial digs in the past month, water main going down to the sewer plant broke. Hard fix, one more on Main Street, curb stop did not work and that lead to an irrigation line that was not on a meter, so we fixed that and then the one on Spring Street. There are three examples that have come from leak detection, just because you don't see us out there doesn't mean that we are not. If you want to follow me around someday please let me know.

Robert Underwood: the first one building code enforcement fund for \$9,100.00 is because we had more inspections that we anticipated. We make a guess every year and he did more than what we thought. The next one gas appropriation fund that fund was passed last year Gina found a grant from HB355 which gave us \$127,000.00 extra which we spent on Spring Street and some on Railroad which made us go over budget \$66,600.00. The next one is the airport fund \$17,500.00 that was a fuel purchase, and they have recovered that money at this time. The last one is gas appropriation fund, allowing us to take 25% of the money received and put it in a street equipment capital asset fund so that we can track what we can by for equipment and that is moving the money into that street equipment capital asset fund.

Mayor Michalson: council have any questions? Public comments? Seeing none, Jenelle please take the vote.

Councilmember Barker: aye.

d. Discussion/Decision: Resolution No. 574 a Resolution for Adopting a Budget and Adopting Wages and Salaries for the Town of Stevensville, Montana FY 25/26

Mayor Michalson: introduced new business item d, Resolution No. 574 a Resolution for Adopting a Budget and Adopting Wages and Salaries for the Town of Stevensville, Montana FY 25/26. Started budget workshops back in June, there was a laps in July because some things did not come in on time, a few meeting ago the mills were passed. I would like to ask that this is your budget hopefully because of a glitch in the Bitterroot Star we were not able to have this at the last meeting, and as you know the SCADA system at the wastewater is barely working, so passing this budget tonight along with other things moves everything forward. All that I would ask is that when I get a motion and a 2nd if it okay with the council to open it up to Robert and Gina and they can go through it with you. I would ask the council that if they have any questions that they direct them to Robert and Gina. And once those are done I

will open it to department heads, they can have questions and then after that the council has had its say and then I will open it up to the public.

Councilmember Bragg: I move to adopt Resolution No. 574 a Resolution for Adopting a Budget and Adopting Wages and Salaries for the Town of Stevensville, Montana FY 25/26.

Councilmember Barker: 2nd.

Mayor Michalson: motion and a 2nd. Robert and Gina.

Robert Underwood: let's start with wages, nothing has changed from the last two meetings that we have had. I will go by section because I do not think that we need to go line by line again, so if you have a question ask. We did a 2.5% raise to everybody and a couple of targeted raises in the police department. Went back up to \$275.00 for councilmembers.

Mayor Michalson: and we have a 20% reserve this year, correct?

Robert Underwood: correct. Questions?

Mayor Michalson: no questions from the council on the wages, Robert, you can move on.

Robert Underwood: The sheet that you see here is the overall budget, what you are approving is the overall appropriations, your cash has changed from the last time because we have been working on our reconciliation so we could close the books. If I go line by line, you have had this since the 15th of August to look at, I sent out the changes from the last budget worksheet those were all in the budget that was sent out to you on the 15th are there any questions on the budget.

Mayor Michalson: how would the council like to do it, line by line or section by section?

Councilmember Smith: whatever is best for the people.

Robert Underwood: that is a lot.

Councilmember Smith: I have been looking at this for the last two days and I am cross-eyed.

Robert Underwood: if there are any questions on any particular item. You have revenues that have not changed, a 2 mill levy for \$7,000.00 that is going to be on the taxes from the wind damage. Cannabis money, business license, taxes, licenses and permits, charges for services (SRO), swimming pool, court, misc. revenue is the

insurance claims for wind damage. Stevensville Fire gave us money for electricity. Rental for the fire department. Investments. Planning fund, TIFDT fund.

Mayor Michalson: is that going to sunset?

Robert Underwood: it is going to sunset, to keep that from happening you have to borrow from it for a project. TEDD district, it will sunset next year so we have some time to look at a project for the airport. Building code enforcements, lighting districts, police training funds. (went through the funds that had no changes). Capital asset fund, putting money in there from water. Transferring from water to asset fund.

Mayor Michalson: I would like to add that in regard to that water asset fund, we had a meeting with Eli Malloy of HDR, and he informed us that there are grants out there for storage tanks now, and as we know the town needs one, we haven't heard if there is a match or not, but it is good to know that we will have some money to help with the match.

Robert Underwood: Leak repair to finish up the project. Sewer assets, all of the money for the sewer investment will go in there, the operating fund.

Mayor Michalson: I would like to add about the sewer the SCADA system on the sewer end is limping along barely, our plant is nearing the end of its life span. Things are going to start breaking down even more, thank goodness that we have money set aside in the capital asset fund.

Robert Underwood: airport fund, the biggest thing is the fuel, then collecting fees. Here is the up-and-coming project for the fuel tank.

Mayor Michalson: Discussion from the council? Jeff, Steve and Brian any questions on the revenue side of the budget. Public comments?

PUBLIC COMMENT

Vicki Motley: on the TIFDT you said that if we don't use it we lose it?

Robert Underwood: no.

Gina Crowe: we just don't get any more.

Jim Tadvick: the bond that we have, have we reduced the principal on that at all?

Robert Underwood: every year it goes down a little bit.

Jim Tadvick: what is the balance?

Robert Underwood: off of the top of my head I do not know. 40-year bonds, I think that we are in year 5.

Gina Crowe: they are all different.

Robert Underwood: the things with these bonds is that you will have to replace your plant before you ever pay it off.

Mayor Michalson: okay with the council if we move onto the expenditures.

Robert Underwood: instead of going line by line I am going to go by account. Legislative services, Professional services the mayor, City Court, Prosecuting services, general fund, administrative portion of the town, election, legal services, town hall (building and annex), police department, fire department is broke into four different accounts; fire station here, fire station at the airport, suppression, ambulance. Public works administration (general fund portion) Street services, lighting (main in town, some are paid by lighting districts), cemeteries, parks, forestry and nursery, swimming pool, splash pad that is the total expenditures for the general fund. Planning fund, TIFDT money, TEDD district, drug money, building code, lighting districts. Police pension fund/training fund, gas appropriations. Capital assets.

Mayor Michalson: our water right attorney fees do they come out of that.

Robert Underwood: yes, they come out of that. Water, capital overlay, sewer, capital asset from sewer, tires and replacement bulbs. Airport, projects for the fuel tank and pavement. If you look at that it is all right here. Expenditures and the Revenue is on the next chart. Bottom line at the end of the year we are going to a 23% cash reserve.

Mayor Michalson: Gina, can you give me what we made on interest this year.

Gina Crowe: 116,000.00 and is split between general, water and sewer. I will assume that it will stay about the same if the interest rates stay about the same.

Robert Underwood: it is based on the interest rates.

Mayor Michalson: any questions from the council. I know that you mentioned earlier about the EMT's.

Councilmember Smith: I move that we add to the fireman's training, and I hear that about 3 EMT's would cost about \$3,000 so we are looking for that. So, I would move that we move \$3,000 into the fire department training fund.

Councilmember Barker: 2nd.

Mayor Michalson: Motion and a 2^{nd} . Discussion from the council on the amendment?

Councilmember Smith: after listening to the chief it is important to get and keep our fire department and our fire fighters and that is why I am all for that.

Councilmember Barker: how many are you sitting at right now for your department.

Chief Motley: I think it is either 13 or 14.

Mayor Michalson: any other comments on that motion.

Chief Motley: Where do you want to put that money, EMS training or fire training.

Cuncilmember Smith: where do you need the money the most.

Chief Motley: I will put that back to Gina and Robert and to what account to put it in.

Gina Crowe: EMT,

Chief Motley: I here that you want to fund EMT.

Councilmember Smith: it could be either EMT training or the other, what does the fire department need most.

Chief Motley: we need people; we need training feasibility.

Councilmember Smith: then I would amend that it goes to the training that he just mentioned.

Chief Motley: EMS training.

Mayor Michalson: Jenelle take a vote on the amended motion for the training for the fire department.

Councilmember Smith: aye.

Councilmember Barker: aye.

Councilmember Bragg: aye.

Mayor Michalson: passes 3-0

Councilmember Smith: I guess it is at this point, I have a couple concerns. First off I would like to move that when we are passing the budget it is probably the most important thing that we do. And it would seem to me that we should have all of our

councilmembers here. So, I would like to move to table this until the next meeting when we have all of our councilmembers here to give full input.

Mayor Michalson: we have a motion on the floor to table this budget.

NO 2nd.

Mayor Michalson: seeing none, we will move along.

Councilmember Smith: then I move to table Resolution No. 474. Frankly this budget is not balanced. When it comes to mathematics I am not a scholar, but I can do basic arithmetic and going through the very first page in the packet that is a different first page on our desk today when we walked in. it says on the formula up here to get line number 7 we have to add 5 and 6. On the very first line we have line 5 and line 6 and it does not add up to line 7. A \$26,000 error right there. This budget does not balance on that alone, so we cannot pass it. I would like to table this to next session so these things can get corrected, and I have a few other things to.

NO 2nd.

Mayor Michalson: seeing none, the motion fails.

Councilmember Smith: I am still going to move to table this until next regular meeting because if you were to look at MCA 7-6-4020 and we are supposed to be approving wages and salaries and what have you. It says in letter F. (read letter F) there should be a separate document listing the positions and salaries and the people have not had that opportunity to see the wages and what have you. My motion is to table this until it can be corrected.

Mayor Michalson: with that there is a motion to table the meeting.

Councilmember Barker: this is just for the wages that you want to see?

Councilmember Smith: but it is not included in the packet for the people. They did not get to see this.

Councilmember Barker: how did we do this in the past.

Councilmember Smith: how I understand it the resolution should be two different resolutions. We can't really separate the resolution we have to go with how it is written.

Councilmember Barker: we have passed this in the past with no other discussion I do not understand when it could have been brought to the town hall before this especially because I know this, I came in to go over the whole budget with Gina and

she sat down with me and went line item by line item and answered my questions I guess I am confused why we waited so long and now bring it in front of everybody, we emailed back and forth when we need something from the town why was this not something that was brought up.

Councilmember Smith: do you want my explanation; I only saw it two days ago.

Councilmember Barker: the packet has been out for over a week it comes out on a Thursday.

Councilmember Smith: no, the packet has been out since Tuesday. Because it was.

Councilmember Bragg and Barker: last Thursday.

Councilmember Barker: I previewed it last Thursday in the packet.

Councilmember Smith: the actual agenda and all of the amendments were on Tuesday evening at 5 o'clock.

Mayor Michalson: no sir.

Councilmember Barker: just the additions.

Jenelle Berthoud: minutes and claims.

Councilmember Bragg: Thursday 9/4.

Councilmember Smith: whether or not I saw it two days ago or a week ago it is still a problem here where we have to have it for the people and it is not there. They have the right to know and participate.

Mayor Michalson: I am still looking for a second on this motion to table this.

NO 2nd.

Mayor Michalson: motion fails. Any other questions from the council. I will turn it over to the department heads.

Councilmember Smith: I have had enough of this (walked out of the meeting.)

Mayor Michalson: public comment?

PUBLIC COMMENTS

Steve Gibson: I just have a comment on the bonds, the town decided at one time to refinance the bonds, and you all agreed to that, by the time I got there the rates had gone back up. I would strongly suggest that if they continue to go down and take the

burden off of the people. There is a way. In the near future I would follow the interest rates for the people of Stevensville.

Councilmember Barker: can I ask Mr. Tadvick. Can you explain that, being in the banking industry, can you explain that if you have that knowledge.

Jim Tadvick: I really can't explain that either, Robert can better than I can.

Robert Underwood: at one time it was brought in front of the council and the council said yes, there was some stuff going on and it did not get done during the transition between me and the other finance officer and the interest rates went up and for us to do that now it would have to be below 3%.

Mayor Michalson: any other comments on the budget from the public?

Leslie Tadvick: I have a question do you all have a budget at your home and you have a certain amount of money coming in and going out, why is this budget not balancing income and debt or whatever, why does it not balance, I agree with Wally and I think that you need all of the council here, I do not think that it is right that you pass a budget that is not correct and I think that I have heard that all around town.

Mayor Michalson: Robert can you explain about balancing the budget, it came up before.

Robert Underwood: the only thing that you are talking about is the general fund out of all of the funds and that is the tightest fund. As long as I have been here, we have spent it down. If you look at last years budget we did not spend all of the money, 87%, so that is why we have more cash in the beginning of the year. The requirement is that we cannot be over 30% and we will be at 21% and we are targeted to be on track. You are right if we had extra money we would be putting that into a fund, and right now we do not have that extra cash.

Steve Gibson: Robert I think you said that the largest revenue is the general fund.

Robert Underwood: no, the only one that can be spent down is the general fund.

Jim Tadvick: what do you do now that Wally has walked out.

Jenelle Berthoud: we could take a recess.

Mayor Michalson: we started with a quorum.

Jenelle Berthoud: I have been doing this same thing in my head, and we started with a quorum at three and then our quorum is all that we need to have is 2? The required majority.

Steve Gibson: with two people you do not have a quorum, so you are saying because you started with three.

Mayor Michalson: it would still be a quorum. At a regular council meeting we start with four and one walks out we have 2/3 tonight we started with three one individual got up and walked out and we still have two and that is still 2/3 and is still a quorum.

John Dowd: you had mentioned that it does not balance and that it is built on the money that comes in and out.

Robert Underwood: what I am saying is if we spend the budget down 100% we will have a cash reserve. Next year would be tight. But every year we have done the same thing.

John Dowd: the cash remaining.

Robert Underwood: if we were to spend the entire budget, we would have this amount. And then another 3,000 for training.

John Dowd: and that is in the general fund, by state law you can have no more than what.

John Dowd: I want to clarify again, how much by state law are you allowed to have?

Robert Underwood: no more than 30%.

Jeff Motley: and no less than?

Robert Underwood: 12%, we are good. In cash reserve.

Steve Gibson: this is state government, they talk about it all the time, there is not law on how much surplus you can have. It is between the council and the executive, but I am not aware of any state law.

Robert Underwood: in the general fund, yes.

John Dowd: you say that you can be fined?

Robert Underwood: yeah, in the audit. That means theoretically we would be collecting more taxes than we are supposed to. If we went over and the simplest thing to do would be to put it in an asset account in the budget.

Councilmember Barker: so, can you explain why it is not showing in revenue that number why those are not.

Robert Underwood: when you talk about, I took out investment income, if you look at the state chart is just want make sense. (unclear audio).

John Dowd: the money that Wally is referring to.

Robert Underwood: yes, \$26,000.00.

John Dowd: (unclear audio)

Councilmember Barker: so those numbers there equal to that nine hundred forty.

Robert Underwood: yes.

Mayor Michalson: any further comments from the public?

Robert Underwood: I just want to say, this has been out for almost a month, August 15th, my point is if we are a team and we work for the team, then bring it up. Nothing is going to change next week.

Jim Tadvick: doesn't it have to be published?

John Dowd: in its entirety, and it was last week.

Robert Underwood: that same packet went out with revenue and expenditures.

Jenelle Bertoud: the first time that the information was to go to the newspaper, that resolution and the budget were immediately sat at the table in town hall for anyone to view. Almost 8 weeks.

Mayor Michalson: Jenelle, please take the vote on the budgets.

Councilmember Barker: aye.

Councilmember Bragg: aye.

Mayor Michalson: passes 2-0 and that is a quorum.

Board Reports

Councilmember Barker: Planning and Zoning Board met last night, and we had HDR Engineering as a guest. We talked about our infrastructure, and the water tank and we talked about the grants that are out there, and I know that some of the grants are time sensitive, so they are working on getting those out as soon as possible. We want the public to come and be involved in those meetings, two citizens that came and gave us some input.

11. Town Council Comments

Councilmember Barker: I just want to give my prayers to those that were effected yesterday and the Utah shooting, Charlie Kurk, it does not matter what party you are, we are all still Americans. I give my condolences from 9/11.

12. Executive Report

Mayor Michalson: 9/2/25 Steve, Jenelle, Gina, myself, Councilmember Barker, met with HDR about past and future projects that we will be adding to the growth policy. On 9/3/25 all of the town staff held a harassment training with Derek Shepard with MMIA and then in the afternoon we had a breakout session about the hiring process. On 9/10 I had a meeting with Chad Smith, Valley Drug owner about the community center, they are going to pass on that. Now there is talk that they are considering selling that and that they do not have sewer. I do not think that it is a priority of ours to run a sewer line down Park Street for one house, Chad understood that. There will be a meeting at the library about this, and I will be attending that. Today I went to the 9/11 ceremony in Stevensville at Veterans Park. They had a procession and then read the names of those that lost their lives.
